The Council reaffirmed the position of the voting today to the Council members and Oyarifa observers. This reiterated the fact that seven (7) house heads would cast votes on three (3) houses, Nii Owusu We, Nii Kplen We and Nii Otopa We. The victor house would nominate a candidate for vetting. The 2nd and 3rd positions would assume positions as and when the time comes in that order before 4th, 5th and 6th positions - Nii Kpobi We, Nii Awua We and Nii Asua We respectively in that succession order. The former houses will be introduced to the La Traditional Council members as part of a written document at the appropriate time by the Supreme Council of La-Agbawe.
