The Ghana Youth Manifesto (GYM) Coalition lauds Ghana's New Government led by His Excellency John Dramani Mahama for the establishment of the Ministry of Youth Development and Empowerment by Executive Instrument on 9th January, 2025, under Section 11(3) of the Civil Service Act, 1993 (PNDCL 327). The Coalition highly commends his Excellency, President John Mahama for fulfilling one of the crucial campaign promises of the National Democratic Party to the Youth of Ghana. The call for an independent Youth Ministry has been ongoing for decades and we are excited to finally witness its creation under this regime.
