**DISREGARD FALSE CLAIMS MADE BY KEVIN TAYLOR AGAINST DR.

We act and write as Lawyers for and on behalf of **DR. (MH) WILLIAMS SARPONG ANARFI** (our client).

Our client informs us that on Wednesday, 26<sup>th</sup> February, 2025, one Kevin Taylor, made some false claims against him on a Facebook Live programme on a Facebook page known as Loud Silence Media entitled:

**“THE PRESIDENCY MUST DISASSOCIATE THEMSELVES FROM WILLIAM ANARFI SARPONG”.**

Our client also informs us that the said Kevin Taylor repeated the attacks on him on Thursday 27<sup>th</sup> February 2025 and Friday 28<sup>th</sup> February, 2025 on the same Facebook live programme on the same Loud Silence Media page.

We note regrettably, that in the said programme, Kevin Taylor sought to mislead the general public to impugn and bring to disrepute, the hard-earned reputation of our client by making false and baseless claims against him. On the same programme, Kevin Taylor also exposed our client and his family to threats by inciting harm and hate against them. He posted pictures of his parents and mentioned all the names of his siblings on the programme, creating a very bad image of them. He also called on the relevant authorities to shut down our client's hospital.

Our client strongly believes that these personal attacks on him and his family by Kevin Taylor could only have been motivated by a motive to get our client and his partners to back out of a business transaction they

floated to the authorities which appear to have other persons' business interest threatened and who have now hired Kevin Taylor to defame our client by making baseless claims against our him.

We wish to state that our client is not a politician but a medical professional who completed his training and has been licensed by the relevant authorities to practice. our client is the C.E.O of the Spintex Medical Center, which is located on the Spintex road in Accra. Our client is also an entrepreneur.

We also wish to state that our client is not fraudulent and has never been involved in any fraudulent deals with the Presidency of the Republic or anyone else nor is he seeking to defraud anyone, including the Presidency.

We also wish to state that our client does not live in Dubai as Kevin Taylor wants right thinking members of the public to believe. Indeed, our client has not even traveled to Dubai the whole of this year and so the claim by him that our client is currently in Dubai is completely false.

We therefore entreat the general public to totally disregard all the baseless claims that have been made against our client by Kevin Taylor, who is hell-bent on ruining our client's hard-earned respected reputation to serve the interest of his paymasters who may see our client as threat to their business interest.

We wish to state that we have our client's express instructions to institute legal proceedings against Kevin Taylor, his media house and any other person who facilitated the publication, including Meta for defamation.
