### **Amicable Resolution Reached in Legal Matters Between Empress Gifty Oppong Adorye and Evangelist Patricia Asiedua**

The legal disputes between Empress Gifty Oppong Adorye and Evangelist Patricia Asiedua have been resolved amicably. The terms of a mutually agreed settlement were today, 20 January 2026, adopted as a Consent Judgment by both the Tema Land Court and the Tema Main Court, formally bringing the two related lawsuits to an end.

The suits, initially filed on May 20, 2025, and June 26, 2025, stemmed from publications by Evangelist Asiedua which Empress Gifty considered damaging to her reputation. In her original claims, Empress Gifty sought court orders for:

1. The payment of forty million Ghana Cedis (GHS 40,000,000.00) in damages for alleged slander and libel.
2. A perpetual Injunction restraining Evangelist Asiedua from publishing further defamatory statements.
3. The removal of all related content from social media platforms.
4. Full coverage of legal costs and professional fees.

#### **Terms of the Amicable Resolution:**

After constructive dialogue, the parties have settled the matter privately. The terms of this settlement, now entered as a binding court order, are as follows:

1. Payment by Evangelist Patricia Asiedua to Empress Gifty Oppong Adorye of a sum of One Hundred Thousand Ghana Cedis (GH¢100,000.00), covering legal fees and expenses related to the cases.
2. A public retraction of the implicated statements and the issuance of a public apology by Evangelist Patricia Asiedua to Empress Gifty Oppong Adorye.
3. A request to the National Information Technology Agency (NITA) to remove the subject publications by both parties from social media platforms.

Evangelist Patricia Asiedua has since the agreement paid the amount involved of one hundred thousand Ghana Cedis (GH¢100,000.00) in full to Empress Gifty Oppong Adorye and has further rendered a public apology to her.

With the entry of the Consent Judgment, Empress Gifty Oppong Adorye has agreed to irrevocably relinquish all claims and/or demands in respect of and/or in connection with the subject matter of the suits against Evangelist Patricia Asiedua.

The adoption of these terms by the courts provides a final and binding conclusion to the disputes, which is in the best interest of all involved. The focus now is on the future.
